**\*\*\*NOTICE OF CHRISTMAS HOLIDAY CLOSURES\*\*\*  
Christmas Day and New Year's Day Observed**

(Douglas County, Ore.) Douglas County Commissioners, Tom Kress, Chris Boice and Tim Freeman, would like to remind citizens that county government offices in the Douglas County Courthouse and the Douglas County Justice Building, located at 1036 SE Douglas Avenue in Roseburg, as well as the Douglas County Courthouse Annex (Reedsport), Douglas County Fairgrounds and All External Douglas County Government Offices will be closed to the public on Friday, December 24, 2021, as well as Friday, December 31, 2021, in observance of Christmas Day and New Year's Day Holidays.

Additionally, some County Departments will have limited hours or will be lightly staffed during the holiday season. Please call ahead of your visit to see if the County Department has staff available to assist you with your needs. You can call (541) 672-3311 for general inquires and Department extensions. You can also log onto our website at <https://douglascounty-oregon.us/> to access contact information for each County Department.

As always, even when Douglas County government offices are closed, many officials and public employees are still working. Please note the following exceptions and notices:

- 1) **Douglas County Landfill and Transfer Stations** that are normally open on Fridays, will be open on Friday, December 24, 2021 and Friday, December 31, 2021. Those sites that are normally open Saturdays, will be closed on Saturday, December 25, 2021 and Saturday, January 1, 2022.
- 2) **Douglas County Museum** (Roseburg) will be open on Friday, December 24, 2021 and Friday, December 31, 2021, but closed on Saturday, December 25, 2021 and Saturday, January 1, 2022. The **Douglas County Lighthouse Museum** (Winchester Bay) will be open **every day** except Saturday, December 25, 2021.
- 3) **Douglas County Senior Dining Sites** – Curbside Meal Service and our Meals on Wheels Programs in Glendale, Glide, Yoncalla, Reedsport, Sutherlin, Riddle and Winston will be closed on Friday, December 24, 2021 and Friday, December 31, 2021. Patrons needing meals for those days are asked to request an extra meal from staff during their drive-through visit or delivery the week of December 20, 2021 and December 27, 2021.
- 4) **Douglas County Sheriff's Office**, Deputies, 911 Communications and office staff will continue to provide law enforcement protection and emergency assistance for our residents. If you have an emergency, call 9-1-1. If you need to reach dispatch for a non-emergency, call the non-emergency number at (541) 440-4471.
- 5) **Commissioners, Tom Kress, Chris Boice and Tim Freeman**, along with **Dr. Bob Dannenhoffer, our Douglas County Public Health Officer** and **Douglas Public Health Network** staff will continue to work on our local pandemic response regardless of the holiday.
